REGULATIONS PERTAINING TO WEDDING CEREMONIES AND PHOTOGRAPHY:

- Wedding photography fee is \$100 and is non-refundable. You may reserve another date if required. Maximum, 25 people, limited to bridal party and parents.
- Wedding ceremony fee is \$400. A non-refundable photography fee is additional.
- Cancellation charges of \$200 apply to wedding ceremonies, however, if you choose to reschedule within one year of the original date, we will hold your payment and apply it to the new date. **This offer is valid for one year only from the date of your wedding, after which time we cannot refund any of your payment.**
- Bring permit with you on the day of the event. Park or security personnel will ask to see it.
- Conservatory Garden is a "**Quiet Zone.**" Amplified music and audio equipment are **not** allowed. Stringed instruments are allowed.
- Rules and directives of Park personnel must be followed.
- **Scheduled** (30 minute) wedding photography sessions are permitted on the lawn area.
- Wedding receptions are **not** permitted in Conservatory Garden.
- Alcoholic beverages are **not** permitted in Conservatory Garden. (A summons may be issued for violation of this rule, and you will be asked to leave.)
- Chairs, tents, rugs and/or runners are **not** permitted.
- Throwing rice, birdseed, flowers, and confetti is not permitted

The permittee is liable for all damage or injury to property or persons that may occur or be caused by the use of the permit, and by accepting the permit, the permittee agrees to save the City of New York, the Parks Department and the Central Park Conservancy, Inc. harmless from any claim whatsoever which may result from such use.
